

**TOWN OF FOYIL, ROGERS COUNTY, OKLAHOMA**

**RESOLUTION 2025-1**

A RESOLUTION DIRECTING THAT A GENERAL ELECTION BE HELD FOR CERTAIN TOWN BOARD OF TRUSTEE POSITIONS: DECLARING TIME WHEN POLLS ARE TO BE OPEN; STATING POSITIONS FOR WHICH ELECTION IS TO BE HELD AND STATING TIME FOR COMMENCEMENT AND EXPIRATION OF TERMS OF OFFICE; STATING REQUIREMENTS FOR ELECTION; STATING REQUIREMENTS FOR BALLOT; STATING QUALIFICATIONS FOR CANDIDATES; MAKING CERTAIN GENERAL ELECTION LAWS APPLICABLE; ESTABLISHING PERIOD FOR FILING FOR OFFICES; STATING RESPONSIBILITIES OF COUNTY ELECTION BOARD AND COUNTY ELECTION BOARD SECRETARY; REQUIRING PUBLICATION OF RESOLUTION; AND PROVIDING FOR ABSENTEE BALLOTS.

BE IT RESOLVED BY the Mayor and Board of Trustees of the Town of Foyil, Oklahoma that:

Section I: GENERAL ELECTION: A non-partisan election, if needed, shall be held on April 01, 2025, between the hours of 7:00 a.m. and 7:00 p.m., at the regular polling places for the precincts of the Town, for the purpose of filling the following offices of the Town:


Two (2) Trustees, for a four (4) year term, commencing with the first Town Board meeting after 12:00 noon on April 14, 2025, and expiring in April, 2029.

One (1) Trustee, for a two (2) year term, filling the unexpired 2 years of a 4-year term, commencing with the first Town Board meeting after 12:00 noon on April 14, 2025, and expiring in April, 2027.

Section II: VOTING: The offices of the Town listed above shall be filled by voting at large. The candidate for each position receiving the greatest number of votes for that position shall be elected to the office. The ballot for voting on the candidates shall be substantially in the following form:

Section III: QUALIFICATIONS: Only registered voters who have been resident at an address within the Town for not less than six (6) months prior to the filing period of the election shall be eligible to hold the offices listed above; pursuant to Town Ordinance, there is no ward residency requirement;

Section IV: APPLICABLE LAW: The Rogers County Election Board shall conduct the election, canvass the returns and certify the results to the Town Board. The election shall be conducted in accordance with the provision of the general election laws of the State of Oklahoma;

Section V: FILING PERIOD: The filing period of the offices listed above shall be open for three (3) consecutive days, from 8:00 a.m. until 5:00 p.m. beginning on February 3, 2025, and ending on February 5, 2025, at the office of the Rogers County Election Board, 415 West 1st Street, Claremore, Oklahoma. A petition challenging the qualifications of any candidate for the offices listed above must be filed with the Secretary of the Rogers County Election Board no later than 5:00 p.m. on the second day following the close of the filing period; Any candidate who is unopposed for an office in a general municipal election shall be deemed elected and certified; and his name shall not appear on the general election ballot. If there is only one candidate for each of the offices which are to be filled at the election, and no questions are to be voted upon at the election, the general municipal election shall not be held;

Section VI: FILING WITH SECRETARY OF THE ELECTION BOARD: This Resolution shall be filed with the Secretary of the Rogers County Election Board not fewer than fifteen (15) days before the filing period for the election, or not later than January 17, 2025;

Section VII: PUBLICATION OF RESOLUTION: This resolution shall be published in a newspaper of general circulation in the Town at least ten (10) days before the beginning of the filing period for the election;

Section VIII: ABSENTEE BALLOTS: Absentee ballots shall be provided in accordance with the provision of the general election laws of the State of Oklahoma.
