**ORDINANCE NO. 2025-4
AN ORDINANCE VACATING
THAT PORTION OF SIXTH
STREET LYING BETWEEN EAST
400 ROAD AND LOT I, BLOCK 3
OF THE TOWN OF FOYIL**

THE TOWN OF FOYIL HEREBY
ORDAINS:

Section 1. That the Town of Foyil
deems it necessary and expedient
to vacate that portion of Sixth Street
lying between East 400 Road and
Lot I, Block 3 of the Town of Foyil,
Oklahoma ("Vacated Property").

Section 2. That the franchise hold-
ers in the area of the Vacated
Property, Chelsea Gas Authority,
Rogers County Rural Water District
#3, Public Service Company of Ok-
lahoma, AT&T Enterprises, LLC, fka
AT&T Corp., Southwestern Bell
Telephone Company, LLC, Cox-
Com, LLC and Cox Oklahoma
Telcom, LLC, or other persons hav-
ing a special right or privilege
granted by ordinance or legislative
enactment have consented in writ-
ing to such closing. There are no
other franchise holders or other per-
sons having a special right or
privilege to use such vacated lots
and streets abutting the lots.

Section 3. That that portion of
Sixth Street lying between East 400
Road and Lot I, Block 3 of the Town
of Foyil are hereby vacated.

Section 4. Vacating the Vacated
Property shall not affect the right to
maintain, repair, reconstruct, oper-
ate or remove utility, public service
corporation or transmission compa-
ny facilities or service therein.

THE TOWN OF FOYIL HEREBY
ORDAINS:

Section 1. That the Town of Foyil deems it necessary and expedient to vacate that portion of Sixth Street lying between East 400 Road and Lot 1, Block 3 of the Town of Foyil, Oklahoma ("Vacated Property").

Section 2. That the franchise holders in the area of the Vacated Property, Chelsea Gas Authority, Rogers County Rural Water District #3, Public Service Company of Oklahoma, AT&T Enterprises, LLC, Ika AT&T Corp., Southwestern Bell Telephone Company, LLC, Cox-Com, LLC and Cox Oklahoma Telecom, LLC, or other persons having a special right or privilege granted by ordinance or legislative enactment have consented in writing to such closing. There are no other franchise holders or other persons having a special right or privilege to use such vacated lots and streets abutting the lots.

Section 3. That that portion of Sixth Street lying between East 400 Road and Lot 1, Block 3 of the Town of Foyil are hereby vacated.

Section 4. Vacating the Vacated Property shall not affect the right to maintain, repair, reconstruct, operate or remove utility, public service corporation or transmission company facilities or service therein.
