**REGULAR MEETING**  
**August 14, 2025**

Meeting was called to Order at 6:00 PM

Meeting was chaired by Wm (Bill) Sylvester, Mayor; Other Trustees present were K. McCombs, R. Heenan and P. Sylvester. Others present were Larry Rahmeier, attorney, acting as clerk for recording minutes. And members of public. A quorum was present. Notice had been posted pursuant to law. Rules of Decorum were read.

Motion by Heenan, 2<sup>nd</sup> by McCombs, to approve minutes of Regular Board meeting of July 10, 2025 as presented. The Motion was approved by roll call vote: W. Sylvester – yes, R. Heenan– yes, K. McCombs – yes, P. Sylvester--yes.

Motion by Heenan, 2<sup>nd</sup> by McCombs, to approve payment to Crandall Professional Services for Fire and Life Safety Inspection, and Occupant Load Determination for \$200. The Motion was approved by roll call vote: W. Sylvester – yes, R. Heenan– yes, K. McCombs – yes, P. Sylvester--yes.
