Regular Meeting
October 9, 2025

Meeting was called to order at 6:00 PM

Meeting was chaired by Wm. (Bill) Sylvester Mayor; other Trustees present were R. Heenan and P. Sylvester. Other members present were Thecia Ellis, Town Clerk, recording the minutes and Larry Rahmeier, attorney, and members of the public. Absent, K. McCombs. A quorum was present. Rules of Decorum were read.
