WHEREAS, the Trustees have established a project consisting of the acquisition and construction of a sanitary sewer system to be owned by the Town of Foyil, Oklahoma, and leased to the Authority; and

WHEREAS, in order to provide uniform rates and charges for the sanitary sewer system owned by said town and leased to the Authority, and in order to affect the incurring of indebtedness secured thereby, it was necessary that schedules of rates and charges for services rendered through said system be established and that certain rules and regulations governing the operation of said facilities be established, and such rates and rules were established by Resolution 99-2; and

WHEREAS, the Trustees have determined to modify the monthly Sewer Rate Schedule to reflect the impact of customers' water usage on the sewer system, effective with billings commencing January 1, 2018.

NOW, THEREFORE, BE IT RESOLVED BY TRUSTEES OF THE FOYIL ECONOMIC DEVELOPMENT AUTHORITY:

SECTION 1. Sewer Rates.

There hereby is established the following amended rate (effective January 1, 2018) for the use of the sanitary sewer system of the Authority:

SEWER RATE SCHEDULE (MONTHLY)

\$10.00 per month Flat amount as base minimum, plus \$2.00 per 1,000 gallons of water used.

SECTION 2. Tapping Fees.

There hereby is established a Tapping Fee of \$200 to defray the cost of making each new connection to the sewer system of the Authority, which said sum shall be paid to the Authority prior to the making of each new connection to its sanitary sewer system. The aforesaid Tapping Fees for sanitary sewer connection shall never be less than the actual costs thereof to the Authority, and in the event said cost is greater than the aforesaid Fees, the latter shall be thereby increased.

SECTION 3. Rules and Regulations.

(a) Billing. No free service will be permitted. The Authority will render statements to customers of its sanitary sewer system monthly. The amount shown thereon shall be due and payable by the customer to the Authority upon receipt of the statement.

A late payment charge of ten percent (10%) of the amount due hereby is established. Said late payment charge shall be added to each statement payment of which is not received by the close of business on the 15th day following billing date.

(b) Disconnection and Reconnection. The Authority will cause any connection to its water or sanitary sewer systems or either of them to be disconnected in the event that all sums due the Authority for any utility service furnished at said location, including late payment charges, are not paid by the -10th day of the second month following billing, provided, the Authority may disconnect any connection at any time after billing date if it feels itself insecure. In the event of disconnection for any reason, reconnection will be made only after payment of the sum of \$25.00 to the Authority for each reconnection made, plus all sums previously due and unpaid.

(c) Customers will be billed for any and all damages to meters or fittings not occasioned by the Authority's employees.

(d) In the event any customer causes or suffers to be caused any tampering or interference with the meters, pipes and fittings of the Authority's system, the Authority may immediately disconnect said customers' connection to said system and the authority may require reasonable security prior to reconnection thereof

(e) The Authority shall not be liable to any customer for failures in the sanitary sewer system.
